- Welcome Kelly Gooding, SAC Co-Chair
  - Welcome to new members, reminder of SAC application needed from all representatives
  - Volunteer breakfast being held immediately after the meeting at 8:30, all parent volunteers are welcome
- Principal Update
  - Presentation given to the School Board on School Data and School Improvement Plan
    - Current enrollment, 2009, state of flux due to new enrollees arriving
  - Presentation of Creekside data
    - All test scores continue to go up, to include AP, SAT and ACT scores
    - Creekside teachers teach to the standards
  - Exceeded expectations in the following areas:
    - 448/449 2015 Seniors graduated
    - Overall #1 athletic program in the state (6A) with 18 Varsity sports and no violations recorded
    - Disparities:
      - We improved from 92% to 95% attendance rate, we aim to increase by 2%
      - Increase writing scores by 4%
      - Increase lowest 30% in reading by 2% (73% of the lowest quartile are "proficient"
  - Goals:

- Make school more inviting (Homecoming, co-curriculars) and enforce attendance and tardies (specifically 1<sup>st</sup> period).
- Enhance writing through PLC and WAC
- Upgrade school-wide technologies
- Update on fiscal piece: \$12,900 SAC funds; school recognition funds \$12,000
- Question from Makenna Young (student)
  - Regarding rising test scores: students haven't received their scores. How will scores affect grades?
  - Summer Anderson: EOC/FSA testing will not affect classroom grades, only graduation requirements. Those students effected have been notified.
- Kelly Gooding: SAC request
  - Submitted and required approval prior to this morning's meeting: \$500 for Rachel Kurtz and Miriam Provisero to attend an Art conference in Naples, FL
- Guidance update from Amy Kennair
  - College night will be this evening at 6:00; all grade levels, student and parents are encouraged to attend
- Testing update from Summer Anderson
  - 1425 PSAT's will be given on Wednesday, 10/14; testing will be completed in homerooms
  - Parent Question regarding testing on Saturday College Board dictates the testing days, not the school
